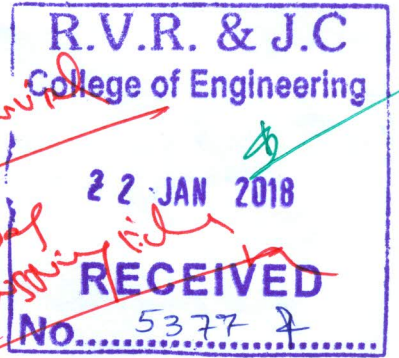

We have received a complaint of ragging from a student of R.V.R. & J.C. COLLEGE OF ENGINEERING. The details are given below.

You are requested to identify & counsel the victim so that he feels safe and knows that authorities are with him & action will be taken on his complaint. You are also requested not to disclose the identity of the victim.

"7.1 Action to be taken by the Head of the institution by the order of Hon. Supreme Court:

on receipt of any information concerningany reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt;
- x. Assault as well as sexual offences or unnatural offences;
- xi. Extortion;
- xvii. Physical or psychological humiliation;

NOTE: Enquiry /Investigation /Disciplinary Committee reports etc. are not acceptable. As per UGC regulations only report of the Anti Ragging Committee is acceptable.

The complaint is stated that, I am threatening to kill him.The actual fact is that Mr.M.V.Yeswanthis discontinued studies long back at our college.He has taken transfer certificate (TC) and relieved from our institution because of his health and personal problems.

I bring to your kind notice that Mr.M.V.Yeswanth and I didn't have any quarrel/disputes/differences during his studies at our college.However, my family having disputes with his family as they are neighbors of my family during our house construction at our village Amadalavalasa, Srikakulam (District). Based on this incident, he and his family want to take revenge on my family and also on myself. In view of that they are trying to spoil my career and my Education.Hence, he is sending fake complaints, false emails and messages to anti-ragging helpline.Due to this, I am unable to concentrate on my education and I am mentally worrying.

I have spoken with the anti-ragging helpline (Toll free Number:1800-180-5522) and they have informed me that they are going to close the complaint as Mr.M.V.Yeswanth is not in the rolls of the college.Hence, I request to kindly treat this as personal dispute among our family member which is not concerned to college. Further he is mis-using the helpline platform to take revenge based on family disputes.

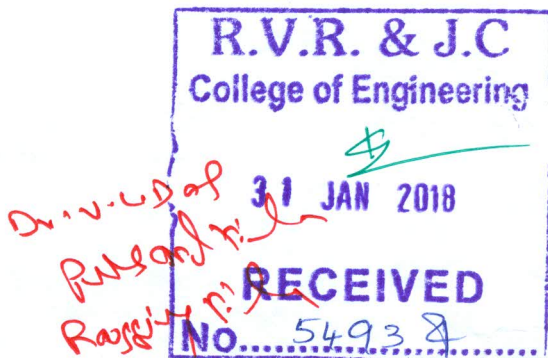

The following points are brought to your kind notice regarding the complaint given by Mr.M.V.Yeswanth Kumar to Anti-ragging Help Line.

1. Mr.Mamidipaka Venkata Yeswanth Kumar, S/o Mamidipaka Vara Prasada Rao, resident of Amadalavalasa (D.No.8-1-24, Market Street), Srikakulam District, Ph.No.9440524872, 8639960380; mail ID: murthykumar0123456@gmail.com; mvyk12345@gmail.com; mamidipaka.yeswanth@gmail.com was admitted in this College into II-Year, EEE branch through the Convener, ECET-2016 under lateral entry.
2. During the year 2017, he discontinued his studies due to health problems and requested for return of all his original certificates vide his letter dated 25-04-2017 and his certificates along with TC were returned. Hence, his name was deleted from the College Rolls List.
3. On 23-09-2017, a mail was received from Anti-ragging Help Line, vide Ref.No.ARCC/AP-3806 regarding the complaint given against four students. It was informed that the victim is pursuing II-Year B.Tech. (EEE) but his name was not mentioned.
4. On 24-09-2017, reply was given to the e-mail, stating that the college Anti-ragging Committee initiated an enquiry and there were two or more students studying with the same name and most of the students had already left due to Dasara vacation. It was also submitted that the enquiry report will be submitted at the earliest.
5. On 26-09-2017, again a mail was received from the Anti-ragging Cell seeking details of the Enquiry Committee members, conclusion of the investigation and punishment for the culprits etc.
6. On 27-09-2017, a reply was given to the Anti-ragging Help Line, duly submitting the list of the Anti-ragging Committee Members and the investigation Committee found that the allegations were not established and found to be false.

7. On 28-09-2017, the Anti-ragging Help Line forwarded a mail, wherein it was stated that the main culprit was living in the victim's village and requested to warn him strictly.
8. On 05-10-2017, details of further investigation done by the Anti-ragging Committee members were submitted to the Anti-ragging Help Line with a conclusion that Mr.M.V.Yeswanth Kumar gave the complaint against Mr.G.Ramesh, which was in no way related to the college and was purely based on his personal / family disputes at their native place, as both the students were neighbours of the same village and that there was no complaint against Mr.G.Ramesh, earlier while Mr.M.V.Yeswanth Kumar was pursuing his studies in the college.
9. On 15-01-2018, a mail Ref.No.ARCC/AP-4102 was received from Anti-ragging Help Line, containing the complaint again made by Mr.M.V.Yeswath Kumar against Mr.G.Ramesh and this complaint was received during Pongal vacation.
10. On 30-01-2018, Mr.G.Ramesh submitted his explanation stating that he was not involved in any ragging activity against Mr.M.V.Yeswanth Kumar which was forwarded to the Anti-ragging Help Line.
11. On 23-05-2018, a mail Ref.No.ARCC/AP-4389 was received from the Anti-ragging Help Line through the Registrar, Acharya Nagarjuna University, containing the same allegation made by Mr.M.V.Yeswanth Kumar against Mr.G.Ramesh, Reg.No.L16EE989. This mail was received during summer vacation.
12. On 25-05-2018, the Principal's report along with Minutes of the Anti-ragging Committee, explanation letter of Mr.G.Ramesh were submitted to the Registrar, ANU as well as Anti-ragging Help Line.
13. On 25-05-2018, a Notice was issued to both Mr.M.V.Yeswanth Kumar and Mr.G.Ramesh, directing them to appear before the Enquiry Committee scheduled to be held on 28-05-2018.
14. Till now, Mr.M.V.Yeswanth Kumar made complaints three times registered with three different numbers (1) ARCC/AP-3806 (2) ARCC/AP-4102 and (3) ARCC/AP-4839. All these complaints were made by him only during vacation periods of (1) Dasara (2) Pongal (3) summer. From the above, it can be seen that Mr.M.V.Yeswanth Kumar is giving complaints whenever Mr.G.Ramesh happens to be at his native place and every time, he is giving complaint using different personal e-mails.
